

## Author declaration

*Pratu: Journal of Buddhist and Hindu Art, Architecture and Archaeology of Ancient to Premodern Southeast Asia* aims to facilitate new scholars' first experiences with academic publishing as they move from student to early career researcher status. *Pratu* therefore welcomes contributions from emerging scholars, and offers a supportive environment for becoming familiar with the processes and requirements of international academic publishing. The Editorial team will work with the author(s) to enhance the quality of their article and facilitate its acceptance for publication in *Pratu*, through processes of editorial feedback, peer review and editing of content. Articles submitted in a Southeast Asian language will also be translated into English. Together, these approaches are intended to increase the potential for international readership, researcher networks and the development of international collaboration.

*Pratu* requests that authors recognise the substantial work involved in the preparation of an article for publication. Several rounds of article editing and development may be necessary, as well as the engagement of external colleagues for technical services. We therefore ask that authors stick to the submission guidelines (<https://pratujournal.org/submit/>) and subsequent deadlines and acknowledge *Pratu's* right of first publication (<https://pratujournal.org/about/>). *Pratu* editors will guide authors through the publication process to help develop familiarity with the expectations of academic publishing.

*Pratu* expects authors to conduct research in a way that is consistent with the principles established by UNESCO's [Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transport of Ownership of Cultural Property \(1970\)](#) and [World Heritage Convention \(1972\)](#). These support the protection and conservation of Southeast Asia's archaeological and cultural heritage, relating to archaeological sites of any size. Authors' research should therefore not knowingly be supported by, or complicit in, activities involving the looting of or damage to sites of archaeological and cultural heritage significance, including the trafficking or sale of illegally-acquired archaeological and art historical objects. To be connected with such activities would represent a conflict of interest. However, this does not preclude the publication of research about illegal networks.

Authors are welcome to use their own images or previously published images to illustrate their article. Responsibility lies with the author to ensure relevant permissions have been granted by the rights holder to publish these images. *Pratu* editors can help with contacting rights holders, including where image reproduction requires payment of a fee. Responsibility lies with *Pratu* to ensure relevant permissions have been granted where we have contacted a rights holder on behalf of an author.
